MANUSCRIPT SUBMISSION GUIDELINES

Authors are asked to comply with the following criteria and format and thoroughly proofread their manuscripts for grammar, syntax, spelling, run-on sentences, and all APA7 criteria.

FORMAT

- Four to five pages (1,250-2,000 words maximum)
- Times New Roman
- 12 pt. font
- 1-in margins (left and right side and top and bottom of the page)
- APA 7 formatted
- Microsoft Word Document *No PDFs
- Images, Figures, and Tables
 - ✓ Should appear when initially referenced in the text
 - ✓ Include all images with your submission and save them as high-resolution .jpg files.

REQUIRED SECTIONS

- I. **Cover Page:** Title of Article, Author(s) Name, Author(s) College or Agency
- II. **Abstract:** 100–200-word summary of the article
- III. **Keywords:** three to five words/phrases
- IV. **Introduction Section** that includes:
 - Type of Research
 - Qualitative (be specific: interview, focus group, survey, case study, other)
 - Quantitative (be specific: survey, descriptive, correlational, other)
 - Mixed-Methods (Quantitative & Qualitative)
 - Other **If so, please contact the Editor before submitting your manuscript.*
 - A description of the problem(s) or type of problem(s) that the research addresses
 - Provide your reader with a road map of your paper. Detail how you organized the paper.
- V. **College or Agency Primer**
 - A. **College/University and Department/Program Background Information**
 - Name of College/University
 - Size of College/University (# of students; undergraduate and graduate)
 - Name and Size of Department
 - Size of Department (# of students; undergraduate and graduate)

- Summarize the entire article.
- Do not introduce new material in this section.
